[One thing to consider is that, disregarding the very different financial situation, things this year should be very little different in both pro and club events as far as the individual volunteer is concerned. And it should be stated in passing that the 'WGI pro worker force' has indicated a willingness to work club events if insurance problems can be overcome. This would certainly be an assistance in staffing events.]

On the financial side it was stated that club dates will be paid for at \$7500/event, which is in addition to the usual expenses (insurance, track damage etc.) that were present in the past. This will take some very close budgeting to try to avoid a large increase in entry fees.

## There will be a training session for race officials, sponsored by the Glen Region with everyone welcome, Apr 22 9AM at the Montour House.


Books giving accommodations for the Shannonville area were given to the REs. Most motels are in Belleville, which is the next city. (Shannonville, of course, is the site of the CNY race in August.) Shirley is booking blocks of rooms in three motels: Black Coach Budget Stay Inn (613) 962–5367; Journey's End 1–800–668–4200; Queen's Motor Inn (613) 966–1211.

(This resume of the Area 10 Meeting, 8 April 1989, at the Day's Inn - Syracuse is based on notes taken by our ex-officio secretary, Emily Castle.)

<u>Insurance</u> - A memo presenting the SCCA position on our insurance program is being sent to all REs. This will try to answer possible questions presented by the letter sent earlier by E&E implying that the 1989 policy with Naughton is not in the best interest of the mambers.

Among other things it should be noted that the present policy, at the same rate as last year, is providing \$5M liability coverage (vs. \$1M last year) and an across the board Participant Accident coverage of \$50K (vs. a scaled coverage with a max of \$25K last year).

In order make this emphatic, the Directors on Monday approved an addition to the GCR which requires that Regions provide insurance coverage of \$50% for PA and \$5M for liability.

<u>NYSRRC Series</u> – Financial statement was discussed with the recommendation that: a. an allocation of \$200 max/event be made to help defray expenses of administrators at the NEDiv Minicon and Roundtable.

 b. we delete sponsorship expenses and give some thought toward providing rewards for volunteers.

Race track site — In keeping with wish—thoughts over the years (and the philosophy that SCCA should have a physical presence in the national race scene by owning, or having an interest in, tracks), an informal survey made last fall of REs indicated that there is an interest in investigating the possibility of obtaining a race venue somewhere in this area.

Phil Henderson has offered to head a search committee (each RE to appoint one member per Region) to determine whether there is general membership backing for such an undertaking and, if so, to start a search for possible sites and to develop a structure plan to enable the work to be implemented.

It was pointed out that this is probably more than any one Region could attempt and that Area 10 has no real entity. To be able to push toward this goal would probably require reactivation of an INEC/Area 11 Council—type organization in order to have officers and to hold physical property. All this would have to be one of the many items included in any overall plan. Phil will work on this with his committee and will present a plan at the next Area 10 meeting, which could be called specially for this if necessary.

<u>Photo ID</u> - Glen Region has ordered and Finger Lakes is ordering equipment. There was some feeling for a <u>united</u> Area 10 insert to be used by all, but it was decided the time was short and for the Regions to use their own initiative. It was suggested that SCCA offer a 'generic' card (no license etc. - purely for photo) for use by Regions. Also the possibility of using pre-cut plastic with adhesive backing to eliminate the need for purchase of a laminater was presented (Larry has since received an OK from Costa on this). It looks as though at least three Regions will have some race officials ready with photo IDs before the local race season starts the end of May.

The question was raised as to what the effect of the new work force system at Watkins Glen would be on club racing there. This is really two questions: one is whether the racing will suffer from lack of sufficient race officials volunteering and the other is the financial consideration of having to pay for track time.

The first brought the usual and valid suggestions of incentive for retaining members with training in a specialty and means of attracting new members to try working a specialty. One theme that was reoccuring was that of reintroducing <u>fun</u> for and <u>appreciation</u> of the volunteers.

### POINTS SYSTEM

Points will be awarded per the 1989 GCR, Appendix B, except, points awarded will be: 20-15-12-10-8-6-5-4-3-2 for 1st through 10th finishing position. ALL additional finishers will be awarded 1 point. There will be only 1 point awarded for the last in class.

### AWARDS

The Champions in each recognized SCCA class plus, ITS, ITA, ITB, ITC, ITE (Enduro) and Club Ford, as determined by their final 1989 NYSRRC points standings, will be suitably awarded at the Annual Awards Banquet on FRIDAY, Nov. 26, 1989 at the Burgundy Basin Inn.


