PART ONE

What's Going On Here? - - My 2005 National Championship Experience

I swept through the right hander at the bottom of the North Course and accelerated up the hill. What was happening? My vision was all gray. I was having trouble seeing. Was I blacking out from G forces?

It was close. Very, very close. Unfortunately I'm not referring to how far behind the leader I was at this year's SCCA National Championships. No, the close part is in reference to my decision whether to travel out to Topeka at all this year. In my usual verbose writing style, I'll explain.

I started the season over a month earlier than is usual for me because I had undertaken no involved projects on the car during the winter. I felt it was close and only needed basic maintenance. Oh, sure it could use a diet. Going with an aluminum head, lightened axles and CV joints, and remaking the body using a vacuum packing method for the fiberglas would likely save about 40 pounds! It would also cost, lemme think, maybe \$7000? Fuhgetaboutit. No, it was a quiet winter for the car. I simply installed 100 pound stiffer springs at the rear to combat the previous season's push, cleaned it up, and did some maintenance.

EVOLUTION

Our first event was in April at Fort Devens in Ayer, Massachusetts for an Evolution School. Devens is now the best location in the northeast in terms of site size but it is a 3 hour drive from Albany. Nevertheless, as in past years I was to make that trip about 10 times during the season.

Ken Hurd, my co-driver, and I both entered the "Challenge" school, which doesn't require 2 seats in your car and uses a "longer, quicker, national style, real world autocross course, complete with quick slaloms and hard shut downs", as described on their website. Our instructors included multi-national champions Pat Salerno and the incomparable Mark Daddio. The event was great because it gave Ken and I about 30 runs each. All that seat time was a real nice way to kick start the opening of our season. And for the record, Pat didn't match my time in my car but Mark, alas, took all of four runs to beat me.



But the car felt nicely balanced and we were optimistic.

AND THE RAIN CAME DOWN

Over the next couple of events however, the push returned as we got up to speed in the car and came closer to its limit. A few rain events actually helped to bring out the weaknesses in the car. And at the worst rain event I've ever driven at the car handled terribly. This was early May at Fort Devens. It rained all day, non-stop and the highest temperature peaked out in the mid 40s. The wind chill for the day hovered around 38. Yet when the event organizers offered the 25 of us a chance to call it quits at 1 pm, we all stayed for more abuse. Bunch of lunatics

The car was horrible. It skittered all over the place and had absolutely no grip. None. Touch the throttle and the rear end tried to pass. Tyson Sawyer has been our main competition in the Northeast and was with us for nearly all our events this year. He is knowledgeable, helpful, fun to be around, and a great driver. Just the yardstick that is needed. At this rain event, Ty was about 3 seconds quicker. I durometered his brand new rain tires thinking that was the difference but they were not much better than my 5 year old tires. Something else was going on.

After another event or two, I dropped the car off at Small Fortune Racing (named after the old racing joke, "how do you make a small fortune in racing? ... start with a large fortune"). Bill Gendron is a long time autocrosser and road racer. He builds his own race cars from scratch including Bill Goodale's A Mod car and his own brand new B Mod and D Sports Racer. He has a good grasp on making a car handle, particularly for the odd situation of Solo II. Truly, not many professionals understand making a car go fast on Solo II courses. He took measurements of my car and ran them through the famous "Mitchell program", a piece of software that evaluates a car's suspension. The diagnosis: the car has excellent characteristics of camber and toe control. That news was pleasing but what the heck was going on with the car? I asked Bill to calculate the rate of the antiroll bars.

The result was surprising. The bars had a stiffness in the thousands of pounds per inch range. They had been designed for a car with poor motion ratios and low spring rates. But over the years I've improved the car and it now has excellent motion ratios, so these big bars don't lose most of their rate through inefficient suspension movement as in the past. Thus the bars were by far the controlling factor for roll on the car. This makes a car harder to drive, gives it less grip, and was the primary reason the car was so skittish in the rain. Bill fabricated smaller, standard anti-roll bars.

TWO WINS!

The first event after that was at Englishtown Raceway, a drag strip south of NYC in New Jersey. A drag race was being run simultaneously and I witnessed a brand new Corvette get bent into a





pretzel and a guy on motorcycle also get bent into a similar shape. Ouch.

I beat Tyson for the first time in over a year and the car "felt great" because there was no hint of understeer. But there are two asterisks to this event. The first is that Ty had some serious brake master cylinder problems. The other is that the course was very tight and featured three 180 degree sweepers of tight radius. I was able to get the car to rotate beautifully on these sweepers; it was almost too easy At a few other faster sections the car seemed a bit loose but I chalked that up to the need for some fine tuning. These points should have set off an alarm in my head, but while the input was there, I didn't process it well. The thought that something was off just kind of lingered in my brain, unexamined.

Next out was another small local event. This time it was at Orange Airport, not too far from Newburgh. They are always well run, fun events, but the runway is very narrow and except for the 180 degree turn at the end of the course everything else consists of offset maneuvers and slaloms. I won out over Tyson here too. He was still experiencing some brake problems but when you're starving, a win is a win. Once again, my butt transmitted the feel that the car wasn't quite right. There was definite input from there into my head but I didn't process it well.

Minutes and motion passed.

Treasurer's Report: Chip Van Slyke, for September we had income from 2 solo events. The final expenses for the June National, including the final catering invoice, have been completed. Chip reviewed for the membership the final race financials.

Solo Report: Bruce Kosakoski, reported that the final Solo event for 2005 was held on Sunday 10/2. The final solo drew 46 competitors and Bruce deemed the event a success. He also reported on the co-sanctioned Solo held at Monticello, which went off without a hitch. Over all the season was a success drawing in some new participants.

Bruce received a report from Nancy Hazzard of the Northeast Alternative Energy Alliance on the Saratoga event and they are asking for our participation again next year in the same capacity as 2005. Jack mentioned the announcement at Mid-Ohio regarding Toyo Tires coming on board next year as the spec tire for the National SM competitors. John Sheridan included that the deal is for 3 years with an extremely attractive awards program

for the class. John also discussed in general terms how the agreement was arrived at.

Kurt Weiss will be stepping down as Chairman of the Competition Board at the end of the year due to informal term limits. Kurt has done an extremely fine job in the face of some very difficult situations and obstacles.
