These Championships would not have been possible without a few things. One of the most important things is the support from family and friends. Another is the sites; the OGS parking lot at McCarty Ave, Columbia Greene Community College, the Seneca Army Depot, and the Clifton Park Center. And yet another is the workers; Andy Furlong, Burt Huiest, Bruce Kosakoski, DJ McArdle, Eric Smith, Lyndon Peck, Joe Sell, Tom Hansen, Byron and Danielle O'Hara, Jim Garry, Arn Bebee, Kevin O'Connor, And the many others that work at all of the events.

We also had some other award winners in 2008.

Cone Hunter: This award has been given to the driver that has hit the most cones while trying to get every bit of time out of the course. While it was supposed to be a fun award, the spirit of the award was ruined at one of our events when a driver intentionally mowed down over 20 cones. So this year we decided to not give out a Cone Hunter award. Instead. I came up with the Cone Hater award. Hopefully this will be a onetime only award as we don't want to encourage this type of behavior in the future. The Cone Hater award winner is DJ McArdle.

Novice Driver: This year's Novice Driver award goes to a driver that came to a couple of events last year and got hooked. He showed up at all of the points events, the Divisional, the GTO National event and the Corvette event this year. With all of this seat time, he was able to show improvement throughout the year. He finished first in his class twice and second at the other four. This added up to a second place finish in year end points. This year's winner is John Danese.

Female Driver: This year we did not have the kind of battle that we did last year. We had 3 drivers that stood out at the first event of the year. Unfortunately the battle never continued as a couple of the drivers did not continue to compete. This driver did a couple more events and finished third in class at every event that she went to. Finishing 7th in season points, this year's winner is Lora Kanetzky.

Most improved driver: This year's winner improved from last year's average finish of 6th by placing 1st once, 3rd four times and had his lowest finish of fourth at the Divisional in his class. He improved his final points position of 7th last year by finishing 3rd in this year's Street Championship. This year's winner is Zeke Wright.

Driver of the year: This year's winner was a tough pick. We had two drivers that really stood out. Last year's Driver of the year winner, Jim Garry, went to the 2007 Nationals in Topeka and placed 1st in C mod giving Mohud its first national champion. This year he went back and did it again,

becoming Mohud's first 2 time national Champion. Add to his previous championship with New England Region making him a 3 time champion. The other driver has had an impressive year for the second year in a row. He finished first at every local event. Finished second in class at the Northeast Divisional. He had the Fastest Time of the Day at 4 events. On the Pax index which levels the playing field, he had 2 events of which his times were highest, 2 seconds and 1 fourth. At the Divisional, he was ninth overall on both days. This driver is Andy Furlong. So now the Solo Advisory Committee had the task of deciding which driver to chose. There were discussions for and against each of them and then we put it up to a secret vote. That vote produced a winner... Sort of. The vote in fact produced a tie. We had 4 votes for Jim and 4 votes for Andy and 1 voter abstained. So now what was I to do? I made an executive decision and made a choice. Sorry to say that I played favorites and picked who I thought was the most deserving and that driver is Jim Garry and Andy Furlong.

Worker of the yea: This year we had three nominees. While all three are deserving of the title, we have only one winner for this award. But first I want to acknowledge the two runners up. The Northeast Divisional would not have been as successful as it was without the leadership of Jim Garry. He was also a member of the Solo Advisory Committee, but he stepped down to allow someone who attends all of the local events to take his spot since the lots we use are not friendly to his car. That was a class act. While he allowed Lyndon Peck to take his voting position, Jim has continued to attend

the meetings offering up his valuable insight from all of his years of experience. The other nominee was Bert Hueist. We are lucky to have him as our Course Designer. His talents as a course designer have been noticed throughout the Northeast Division as his designs have been used for Divisionals and National Tours. Bert is also a member of the SOLO Advisory Committee. Now back to this year's award winner. This guy has been very helpful to the program. He is involved with the planning of the events, as he is a member of the SOLO Advisory Committee. He is instrumental during the events as one of the worker chairs and when the event is done, he still has work to do. He has helped me out with his input throughout the year. And he is helping me right now. This years winner is our Timing and Scoring Chief, Eric Smith.

Looking ahead to next year, we should have another busy year. I would like to schedule at least 6 or 7 points events, 2 or 3 test and tunes, a school and supporting the Adirondack Corvette Clubs Charity event. We have the people in place to make all of this happen, we will just have to try and add to our list of sites so we have a place to hold them. "Each year individuals vacate seats on our various boards and committees and we thank them all for their service and dedication," SCCA President & CEO Jim Julow said. "We would like to recognize two individuals in particular, Jan Rick and Dave Whitworth, who were asked to step down from their positions on major program boards when their company, SPS, became SCCA's official merchandising partner."

# **Revised SCCA Fees Announced**

**TOPEKA**, **Kan. (Dec. 9, 2009)** – The SCCA® Board of Directors finalized its 2009 fee structure for dues, sanctions and insurance. While some areas of the business will experience inflation, others will enjoy decreases.

"Overall, the news is positive for active participants in SCCA," SCCA President and CEO Jim Julow said. "While there are some increases in our fees, we have also found considerable savings on the insurance side that offset these. The cost of running any business continues to rise, but we've been able to find some relief for 2009, which is passed through directly to Regions and our participants.

"Overall, the cost to Regions of running an event will not increase from 2008 to 2009."

Membership dues will increase \$5 from \$60 to \$65. Family dues will increase \$6 to \$101, while spouse memberships will increase \$3 to \$23. This is the first dues increase in three years. First Gear memberships remain unchanged.

Fee increases were offset by a reduction in insurance fees across the board. For the first time in several years, the Club-wide insurance policy was put out to bid, with responses coming from four different carriers.

Additional changes included:

# Club Racing

- Increase Regional and National competition licenses by \$5
- Elimination of distinction between spectator and non-spectator at a flat rate of \$1,400 for liability insurance
- Decrease Club Racing PA Insurance \$5 per car to \$28
- Decrease Driver School PA Insurance \$3 per car to \$19
- Decrease Time Trials/Hillclimb PA Insurance \$3 and \$4 per car, respectively

# Rally

- Increase RallyCross Sanction Fee from \$3 to \$3.50 per car
- Increase Road Rally Sanction Fee for Regional events from \$2 to \$4 per car
- Sanction fee for a 3-day or longer event changed to \$500 per event
- Increase sanction fee for a charity event \$20 to \$70
- Decrease RallyCross Insurance fee \$1 per car to \$4

# <u>Solo</u>

- Increase Regional Solo Sanction Fee from \$3.75 to \$4.50 per car
- Decrease Insurance \$1 per car to \$5

With the changes, the Solo Department has made a policy change requiring event audits to take place within two weeks from the end of the event.

Volunteer Incentive Programs remained unchanged from 2008.

A full list of changes will be listed in the January 2009 Fastrack® news. Additional information about the implementation process and timeline will be communicated at a later date.

# SCCA® Trans-Am® Series Returns In 2009

ORLANDO, Fla. (Dec. 11, 2009) – After a two-year hiatus since its last Champion was crowned, SCCA's Trans-Am® Series will return in 2009, with a planned eight-race schedule for the series which held its first race in 1966.

Five of the eight races were announced today at the Performance Racing Industry show, in Orlando, Fla., as well as the series' title sponsor for 2009—Muscle Milk®.

A joint venture between Sports Car Club of America, Inc. and subsidiary SCCA Pro Racing, the 2009 Muscle Milk® SCCA® Trans-Am® Series will consist of six events in conjunction with some of the biggest SCCA Club Racing events across the country, creating powerhouse SCCA weekends, and two key professional events. Technical rules will be based on the SCCA Club Racing GT-1 class.

"There is a dedicated group of Trans-Am loyalists who have been working to make this happen since our last licensing agreement to operate the series expired in 2005," SCCA President & CEO Jim Julow said. "The rebirth of Trans-Am begins in 2009 with a grassroots-based series that has the potential to grow in the coming years into a full professional racing series.

"On behalf of SCCA and SCCA Pro Racing, I would like to thank Jim Derhaag for his tireless efforts to help put some of the critical pieces together and Muscle Milk for coming on board as title sponsor to make the series a reality."

The series will begin its 42<sup>nd</sup> Championship season March 21-22 at Road Atlanta as part of the Atlanta Region SCCA's season-opening National race. The series has previously visited Road Atlanta 12 times from 1973 through 2002, with race winners including former series Champions Peter Gregg, Pete Halsmer, Dorsey Schroeder, Tommy Kendall, Scott Pruett and Boris Said.

One month later, April 17-19, the series heads from the rolling hills of Georgia North to the rolling hills of Virginia, as part of North Carolina Region's Oak Tree Double National weekend at VIRginia International Raceway. It is only the third time the historic series has visited the historic racetrack, joining 1966 and 2002.

The series treks north of the border May 15-17 to return to Mosport International Raceway for the 25<sup>th</sup> time as part of the Victoria Day Weekend with the SPEED World Challenge Championships—reuniting SCCA Pro Racing's top series from the last 20 years. Pruett won the last series appearance at Mosport in 2003.

The series' lone visit to the left coast is a big one, joining the Rose Cup Festival June 12-14 at Portland International Raceway. The huge, traditional event played host to many Trans-Am Classic races, the last being in 1995, won by Ron Fellows. From 1975-2005, the race circuit held 21 Trans-Am Series races.

One month later, it's back east to the Finger Lakes Region's National at historic Watkins Glen Raceway, July 11-12. From 1968-1998, The Glen held 25 Trans-Am Series races ranging from feature events to participants in the 6 Hours of the Glen to the opening act before the NASCAR Cup race.

Three additional races will be announced shortly.

"We're excited about the return of Trans-Am and are pleased to be able to give something back to the series that has provided so much excitement for race fans throughout the years," said 1978 series Champion Greg Pickett, founder of CytoSport Inc., the makers of Muscle Milk.

All events are expected to be approximately 90 miles in length with no pit stops. Races in conjunction with Club Racing events will have qualifying and race sessions separate from the regular GT-1 competition grouping, so drivers have the potential to run both the GT-1 Club Racing event and the Trans-Am Series event on the same weekend.

# **HISTORY**

The Muscle Milk SCCA Trans-Am Series dates back to its first season in 1966. From 1966-1970, the series held a Championship to crown a Manufacturers' Champion. In 1971, a Drivers' Championship was formally adopted, with both Drivers' and Manufacturers' Championships being awarded through the 2005 season. The series was split into two classes from 1976-1979, crowning Champions in each division. In 2006, two additional races were held, although no Manufacturers' Champion was recognized.

Throughout the years, some of the greatest names in motorsports have participated in the Trans-Am Series. Backdating the Drivers' Championship to the inaugural season, 30 different drivers took titles, with multiple Championships being won by Paul Gentilozzi, Tommy Kendall, Mark Donohue, Scott Pruett, Wally Dallenbach Jr., George Follmer, Peter Gregg, Horst Kwech, Scott Sharp and Bob Tullius. Gentilozzi leads all drivers, with 31 career wins.

SCCA both owned and operated the Trans-Am Series, either internally or through its SCCA Pro Racing subsidiary, from 1966 through 2000. In 2001, SCCA began a series of outside licensing agreements for the series from 2001-2006. In its 41 seasons, the series held 446 separate races.

# Regulations and Administration

Announcements regarding regulations and series administration will be made shortly, although technical regulations will be based on current GT-1 rules from the Club Racing General Competition Rules (GCR) with additional potential safety requirements.

Club Racing events will be operated primarily by the individual SCCA Regions, with alterations to the protest and appeals process to be similar to that of Pro Racing events, managed by the SCCA National Staff. A dedicated technical inspector will be at each Trans-Am Series event, regardless of Club or Pro Racing sanction.
